Students who successfully complete this course will be able to:

- 1. Articulate interdisciplinary perspectives to understanding and interpreting the lives of contemporary Indigenous peoples in Canada, including history, art, literature, film, education, law, environmental, and political studies.
- 2. Understand the rights, laws, and rights as Indigenous People in Canada.
- 3. Discuss the ways Indigenous knowledge has survived and is used in modern contexts.
- 4. Provide forward looking, post-reconciliation and indigenized perspectives.
- 5. Focus on inclusivity across Indigenous nations, genders, and culturally diverse backgrounds.
- 6. Understand the foundational history of Canada as a settler-colonial state and how this has led to contemporary events that Indigenous People experience.
- 7. Engage critically upon the future realities facing Indigenous peoples in Canada to provide students with a foundation of understanding the unique place of Indigenous People in Canada in the present.

3. COURSE FORMAT & DELIVERY MODE

The course is broken down into lectures, tutorials and assignments. Read the following descriptions to understand the format for those three components.

Lecture Format

Class lectures will be two hours in length. Lectures will include a variety of teaching methods: traditional lecturing, group activities, out of class hands on learning, storytelling,



creative, expression, and discussion. PowerPoint slides will be uploaded to OWL/BRIGHTSPACE before each lecture. The instructor does not share informal lecture notes. Students are expected to listen and take their own notes during each class. Attendance at lectures is mandatory. *Note: OWL is transitioning over to BRIGHTSPACE. Currently, the instructor is still becoming familiar with the new platform. Please me patient the system is new.

Course Delivery

The course is in-person delivery mode; however, should there is bad weather or the COVID-19 landscape shifts, the course can be delivered on-line synchronously (i.e., on Zoom at the times indicated in the timetable). The grading scheme will not change.

1. (72 hrs) 3 Day Grace Period:

- **Grace Period**: Students will not receive penalty on any late assignments (exempting the Final Examination) for 72hrs if they follow the following procedures. You must follow the procedures below, or you will not be given the grace period.
 - 1) Students will have to submit via the **submissions box** any late assignments. **A submissions "box"** will be provided outside the office of the instructor. Students will be given that information on the first day of the class. It is not included in the course syllabus for safety reasons. Make sure you know where the office is located. The office will be announced the first day of class; however, if you are not there, you are responsible for finding out this information.
 - 2) Students will have till 3:00pm each day to submit a hard copy of their assignments outside the instructor's office. Emailed submissions will not be accepted by the instructor or tutorial leaders. Additionally, you must have the date submitted after the due date on the title page to get proper credit that you made the deadlines.

 - 4) Academic Consideration requests may be granted only for extenuating circumstances that <u>started before</u> the deadline and <u>lasted longer</u> than the No-Late-Penalty Period (72 hours).
 - 5) Alternatively, the instructor may deny all requests, give them a zero mark, and let students follow the appeal pathway to ask for an exception. Note that instructors may not ask for medical documentation for privacy protection, but the student can voluntarily share information.

2. Late Penalties:

- Applied after the grace period; 72 hours after submission.
- 0.5% per day. This lasts for the 1st and 2nd day the assignment is late
- 1% per day 3-7
- Failure on the assignment will be applied day 8 at 12:00 am
