# Indigenous Studies 4903G Indigenous Research and Methodologies

**Course Description:** This course adopts a critical approach to establishing the relevance of post-colonial Indigenous research and methodologies to the global project of decolonization. Inviting students to situate themselves within the research process, it combines theory and practice, utilizing lectures, self-study and interactive process.

- Antirequisite(s): N/A
- **Prerequisite(s):** Any course in Arts and Humanities or Social Science and registration in third year or higher.
- Prerequisite checking is the student's responsibility

## **Learning Outcomes:**

Students who successfully complete this course will be able to:

- A. Demonstrate understanding of the historical and contextual issues (including the intersections between White Supremacy, hetero-patriarchy, and neo-liberalism) that have and continue to shape the evolution of post-colonial Indigenous research methodologies globally, the philosophies and agency-imperatives that underlie their emergence, as well as their relevance for a diverse range of displaced and culturally dislocated groups.
- B. Critique major dominant paradigms including the ways knowledge production is shaped by power relations of colonization and its continuing forms.
- C. Demonstrate understanding of relational epistemologies as an overarching framework within which postcolonial indigenous methodologies are situated, including the ways these can draw on paradigms and methodologies from Western traditions that are commensurate with the goals of decolonization.
- D. Demonstrate understanding of the mobilization of basic principles of Indigenous post-colonial research within a specific context including the ways in which their own cultural identities (broadly defined) are situated within the research process

#### **Methods of Evaluation:**

- 1. Research essay (1200 words) and 10-minute class presentation, 20% of final grade
- 2. Reflective Diary presentation 5% of final grade
- 3. Research Essay (3500 words), 40% of final grade

### **Important Policies**

#### Policies for Assignment Deadlines

Extension of deadlines or alternate dates for tests will be granted only for documented illness or compassionate reasons. Workloads (i.e., other class work, projects, readings, employment) do not count as a reasonable excuse. Late submissions will be penalized at a rate of 4% per day, to a maximum of 20%. Should you have a concern regarding the grade you received for an assignment, you **must wait 24 hours** from the receipt of the grade (on OWL) to contact the instructor. In doing so, *please make an appointment and prepare in writing, with evidence, why you feel your grade is inappropriate.* Please be aware that in requesting a grade reassessment, your grade could go up/down/or stay the same. Note that calculations errors (which do occur!) should be brought to my attention immediately.

# Academic Consideration for Missed Work

Students who experience an extenuating circumstance (illness, injury, or other extenuating circumstance) sufficiently significant to temporarily render them unable to meet academic requirements must submit a request for academic consideration through the appropriate route:

- (i) For <u>absences 48 hours or less</u>, students can complete a <u>Self-Reported Absence (SRA)</u> form provided the conditions specified in the <u>Senate policy</u> are met. The form <u>can be completed online</u>. The SRA can be used only twice. Please note the important exceptions to this rule:
  - i. Not permitted for final exams or assessments worth more than 30% of a course.
- (ii) Students whose absences are expected to last <u>longer than 48 hours</u>, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of a course, the student has already used 2 SRAs, the absence is during the final exam period), may receive academic consideration by submitting a <u>Student Medical Certificate</u> (for illness) or other appropriate documentation (for compassionate grounds). Students are encouraged to contact their Academic Counselling unit to clarify what documentation is appropriate.

## Students seeking academic consideration:

- Are advised to consider carefully the implications of postponing tests or midterm exams or delaying handing in work.
- Are encouraged to make appropriate decisions based on their specific circumstances, recognizing that minor ailments (upset stomach) or upsets (argument with a friend) are not normally an appropriate basis for a self-reported absence.
- All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence.

Academic consideration is not normally intended for the following circumstances:

- Students with an ongoing physical illness or mental disorder (recurring or chronic) or an existing disability are responsible for determining, in consultation with their doctors or other health professionals, if they are capable of pursuing their studies and, if so, with what accommodations. Students are expected to seek and arrange reasonable accommodations with Student Accessibility Services (SAS) as soon as possible in accordance with the Policy on Academic Accommodation for Students with Disability. Students with pre-existing accessibility plans arranged through SAS may not need to provide additional documentation when seeking academic consideration where such request for consideration relates to their disability and where their accessibility plans allow for coursework deferral or deadline extensions.
- Students who experience high levels of stress related to academic performance (including completing assignments, taking part in presentations, or writing tests or examinations). Students with academic or exam stress should access supports through Student Health and Wellness and

<u>Learning Development & Success</u> in order to deal with this stress in a proactive and constructive manner.

# A Note on Plagiarism

Students must write their assignments in their own words. Whenever students take an idea from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing such as footnotes or citations. Plagiarism is a major scholastic offence as outlined in the <a href="Scholastic Discipline">Scholastic Discipline</a> policy.
